This is to certify that insurance cover has been effected with Liberty Mutual Insurance Europe Limited, trading as Liberty International Underwriters, Policy No. 1000032163-20, covering any Scouting Authority's legal liability for an undertaking given to any other Authority or Organisation, subject always to the policy terms and conditions, in respect of permission granted to any Scouting Authority to use the property of any other Authority or Organisation for an agreed purpose during the period 1 January 2021 to 31 December 2021 both days inclusive, GMT.

It is agreed that the policy will, subject to its terms and conditions, indemnify any Authority or Organisation jointly with the Scout Association in respect of liability which arises out of Scouting activities (including first aid and those undertaken outside or away from the normal meeting place) up to a limit of GBP 10,000,000 any one occurrence or all occurrences of a series consequent upon or attributable to one source or original cause unlimited during any one Period of Insurance but in the aggregate, in respect of liability arising from Products or for Pollution and Contamination.

Please note, that in relation to indemnity agreements, hold harmless/ liability waivers or lease agreements The Scout Association, agrees to indemnify a third party for claims arising from the negligence of its Members, Servants or Agents, but will not indemnify a third party for claims arising from the fault or negligence of other parties. For the avoidance of doubt any agreement entered into by a Member, servant or Agent which includes an indemnity provision that exceeds the limitations set out above is not indemnified by the Association or Liberty.

Significant Exclusions, Limits, Terms and Conditions:

Territorial Limits: Motor Vehicles:		Anywhere in the world Including the use of any mechanically propelled vehicles other than liability for which compulsory insurance or security is required by Road Traffic Legislation.
Water Craft:		Including liability for the use of hand or foot propelled craft, sailing craft, or other craft not exceeding 5 metres in overall length, within inland or coastal waters of Great Britain, Northern Ireland, the Isle of Man, but extending to inland or coastal waters worldwide, excluding USA/ Canada, in respect of British Scouts Overseas.
